Animal Surrender and Relinquishment Agreement

I hereby certify that I am: (a) the guardian (also known as the "owner") of the animal described below; or (b) I am the authorized representative of the guardian or owner of the animal described below. I also certify that I have unrestricted and complete authority to convey, surrender and relinquish (collectively, "relinquish") the animal Family Horse Ranch & Rescue Corp. of Saint Augustine, FL ("FHRR") and I hereby further certify that the animal has not bitten or kicked anyone in the last 10 days.

The animal being surrendered is: Julie a Flea bitten grey Percheron horse

By relinquishing this animal to FHRR, I acknowledge and agree FHRR shall have the sole and exclusive legal right to make all decisions, and to take all action, regarding that animal.

I understand that there is a fee to relinquish an animal to FHRR. If I am unable to pay that fee, I will request to speak to a supervisor.

I hereby acknowledge my understanding of, and agreement with, the following terms and conditions that govern the relinquishment of this animal:

(a) If the animal is of suitable health and temperament, it will be placed in the

FHRR adoption program.

(b) If the animal does not pass FHRR health or behavioral screening at any time during the animal's stay at FHRR, the animal will be euthanized -- which means that the animal will be put to death in the most humane manner possible.

I understand that FHRR offers an alternative to me, whereby I may choose to be notified so that I may timely reclaim the animal before it is euthanized. Subject to the following terms and conditions, my choice regarding that alternative is as follows (please initial on the appropriate line):

_____ I wish to be notified so that I can reclaim the animal before it is euthanized.

_____ I do not wish to be notified before the animal is euthanized and I do not wish to reclaim the animal before it is euthanized.

If I initialed the first option (indicating my wish to be notified so that I may reclaim the animal before it is euthanized), I agree that I must physically pick up and reclaim the animal WITHIN 24 HOURS OF FHRR GIVING NOTICE to me that the animal may be reclaimed. In that regard, I am solely responsible for maintaining contact with FHRR and for providing FHRR with current contact information for me, which is listed below: Telephone Number(s):

If I have initialed above, indicating that I wish to be notified before the animal is euthanized, and if I provide current and correct contact information in the space(s) listed immediately above, I understand that FHRR will, on a one-time basis only:

(a) attempt to contact me by email at one of the email addresses that I provided above; or

(b) attempt to contact me by telephone using one of the telephone number(s) that I provided above (if direct telephone contact is not made with me, an acceptable alternative contact for purposes of this Agreement will be that a FHRR representative leaves a message on my telephone or with the person who may answer that telephone). If I have not physically and actually reclaimed the animal within 24 hours from the time of FHRR's email notification, attempted email notification, telephone notification, or attempted telephone notification (by message), the animal will be humanely euthanized.

If my contact information is incorrect or becomes obsolete, and I do not immediately provide FHRR with current email and/or telephone contact information, FHRR shall not be obligated to search for such contact information (and FHRR's effort to contact me using one of the email addresses or one of the telephone numbers provided above shall be all that is required of FHRR for purposes of notifying me of the pending euthanization of the animal.

I hereby release FHRR and its employees, staff, agents and/or representatives from any claims or demands that I have, or may have, that: (a) may be connected with the animal; (b) may arise out of FHRR's care of this animal; or (c) may arise out of FHRR euthanizing this animal.
